124212 The Bluebells, Church Lane, Scotter – a planning application to provide a sun room extension to the rear of the dwelling.

No objection/comment.

124281 Land adjacent to 14 Gainsborough Road, Scotter – a planning application to erect a detached garage.

No objection. However, the Clerk is to make the following comment: "Whilst my Council does not object to this application in principle, it has concerns regarding the design of the proposed garage. It would wish to see the application amended so that the style of the garage is more in keeping, and sympathetic with, its surroundings on the street scene."

124291 45 Gainsborough Road, Scotter – a planning application for the demolition of existing dwelling and construction of replacement dwelling.

No objection. However, the Clerk is to make the following comment: "My Council has no objection to this proposal as the site is suitably sized to accommodate this very large and imposing dwelling. However, considering the dwelling's imposing nature (particularly in

comparison with other properties on the stre	eet scene), my Council asks that a condition be
imposed that the trees on the site's boundar	y facing Gainsborough Road are retained."
