P31 2006/07 - DETERMINATION OF M06/P/0769

The Chairman explained to the Committee that an invitation had been received for the Council to make a representation to WLDC's Planning Committee on 18th October 2006 in relation to the Council's decision to object to this application, which seeks to alter the front and side elevations of No. 52 High Street, Scotter. The Chairman had printed a copy of the Planning Officer's Scheme of Delegation report on this matter and this was circulated and discussed. On the basis of the Planning Officer's recommendation and in light of the improvements to the original design suggested, it was agreed that there was nothing to be gained by attending the meeting.
