#### **General Remarks and Stipulations**

#### Location

The land is situate in the hamlet of Scotterthorpe, in the civil parish of Scotter and to the north of Sennefleet Road.

#### Description

The land is a well kept fenced paddock, suitable for either grazing, mowing or other amenity uses.

#### **Viewing**

The land may be viewed at any reasonable time during daylight hours in possession of a set of these particulars.

#### **Terms of Agreement**

- 1. The land is to be let on a one year Licence Agreement, with effect from 01 June 2021. The rent shall be payable six monthly in advance on 01 June and 01 November each year. A copy of the proposed Licence Agreement is available for inspection, upon request.
- 2. The Licensee shall be responsible for all outgoings.
- 3. The Licensee shall keep and leave in repair all fences, gates, ditches, drains etc.
- 4. The Licensee shall be responsible for all maintenance of hedges and trees, (as applicable).
- 5. The Licensee may not assign or sub-let the tenancy.
- The Licensee will use the land for grazing or amenity purposes but no non-agricultural business use will be permitted.


#### **Method of Letting**

The land is offered to let by Informal Tender. The Parish Council does not undertake to accept the highest, or indeed any offer, but best and final offers of rent should be submitted in accordance with the following:-

- 1. Expressed as a lump sum total per annum.
- 2. Confirm full name and address and contact telephone number of Licensee.
- 3. Confirm what they intend to use the land for.
- Submitted in a sealed envelope marked "Land at Scotterthorpe" no later than 5.00pm on Sunday 16 May 2021 to Scotter Parish Council, 1st Floor, Scotter Village Hall, Scotton Road, Scotter, Gainsborough, DN213SA.

To avoid duplication of offers it is suggested that the tenders submitted should be for an uneven amount of money. The Licensor reserves the right not to accept the highest or any offer, further more escalating bids or offers made by reference to other bids are not acceptable.
