1 2015/16 To receive and approve apologies for absence.

No apologies were received with all councillors present.

2 2015/16 To receive declarations of interest in accordance with the Localism Act 2011.

No declarations were received.

3 2015/16 To approve the minutes of the Council Meeting held on the 16th March 2015 as a correct record.

RESOLVED: to approve as a correct record.

4 2015/16 To agree which Councillors will be responsible for safety inspections of the cemetery and the playgrounds for the next month.

Cllr Day and Cllr Bullivent were happy to continue.

5 2015/16 To receive a report from the Chair on Parson's Field.

The Chairman had nothing to report.

<u>6 2015/16 To discuss the current pricing for exclusive rights to burial concerning the smaller plots</u> (cremation only) in the cemetery.

The Councillors discussed the fact that the price for purchasing an exclusive rights to a plot in the Cemetery is the same price regardless of the size. Following this discussion it was

RESOLVED: to keep the pricing as it currently stands. The pricing is linked to the administrative costs of the cemetery and not the size of the plots.

7 2015/16 To discuss a request from SUFC for a contribution towards work on the conifer hedge.

The request for a contribution to the cost of the conifer hedge height reduction was discussed the Council RESOLVED: not to grant any funds on this occasion. The feeling is that if the hedge had been kept properly maintained the situation would not have occurred.

<u>8 2015/16 To discuss an email received from a parishioner regarding overhanging trees onto the lane</u> leading to the church.

The email detailing the trees overhanging the private road running form the Green towards the Church was discussed by the Councillors. It was

RESOLVED: that the Council do not wish to get involved as this is a private matter between the owners.

9 2015/16 To approve the appointment of R.N. Store to carry out the internal audit for 2014/15.

The Council reviewed the effectiveness of its system of internal audit. Its scope is clearly and comprehensively laid down in the agreed audit plan and the independence and competence of its auditor is guaranteed by the utilisation of an external professional firm of accountants. A suitable relationship exists between the parties to ensure that the audit can be properly carried out and the audit itself is properly planned and recorded. Against this background, it was:
