Councillor Armstrong informed the meeting that there had still been no improvements to the overhanging trees on Susworth Road - the Clerk will chase this.

Councillor Capes reported a pot hole at the junction of Messingham and Northmoor Road, and that the manholes from Charles Avenue going out of Scotter up to Scotter Common are in need of some attention. The Clerk will pass this information on to the Chris Darley at Lincolnshire Highways.

Councillor Capes also updated the Council on two trees that the village person had flagged up.

Councillor Capes feels that the tree in question on Charles Avenue is fine - and the tree on Southcliffe Road should be considered again in the spring.

Councillor Bullivent informed the meeting that the sewage leak on Hobb Lane had now been rectified by Severn Trent.

The Chairman reported to the Council that the Christmas Crib was getting a bit worse for wear, and although he will make it good for this year he has been in touch with Creaseys about purchasing a new one for the next festive season.

A couple of issues with Kirton Road are also reported. There are a number of pot holes that need seeing to - but the more serious issues is that of a car which is permanently parked on the tarmaced driveway at Highfield Farm. The positioning of the car is making it very difficult for two cars to pass safely at that point, as well as forcing lorries turning in to mount the verge on the opposite side. The Clerk will contact Steve Wiles at the highways agency as this is an issue of safety.

The Clerk reported that some damage had been caused to the grass in the new cemetery by the machinery used by a grave digger. The Clerk will contact the funeral director and ask that they use boards if the feel that machinery is needed.
